As a board, we are approaching our differences of opinion professionally – most of us are volunteers and appreciate your patience. This will be Greg Da Ros' last year on the board and he's looking forward to going back to just helping out.

**Financial Report: Peg Mumford**

Things are going really well. We've transferred the management of our financials to Sport Nova Scotia which makes transitions smoother and no worries about losing data between treasurers. We have effectively introduced payment via e-transfers.

Note that our financial year is January to December. As such our 2022 financials are being presented today:

- Revenue and Expenses are comparable to pre-Covid times.

Question: What is NSPPI?

Answer: The Nova Scotia Performance Pathway Initiative is the high performance grant from Sport Nova Scotia. The amount we receive each year is determined by a number of factors including our efforts and the wider sports landscape provincially, nationally, and internationally. We received less funding this year than last because Karate is no longer in the Olympics – it wasn't anything we did wrong on our end.

**Membership Report: Greg Da Ros**

We are up 12% from last year. Not quite where we were pre-covid. This year there are 922 members. Two clubs are still missing from our registration who we were expecting but haven't seen yet. Good to see an overall increase in females raising as well.

Next year will likely see an increase in fees as Karate Canada has increased their fees

**Technical Director Report: Jeff Murphy**
